Dear Ms Mason

I am writing to express NAFI's deep concern at the broadcast of a Wilderness Society "Community Services Announcement" on your station last evening. The "announcement" is unbalanced and inaccurate. It unduly plays on fear, seriously misleading your viewers about Australia's forest management and the future of our forest estate. This is a political broadcast, soliciting funds for a radical lobby group active in the political process. It is not a "community services announcement" and clearly violates industry's Code of Behaviour and breaches advertising standards.

Australia's native forests are managed by State forest agencies to world's best standards. Australia's forest are not disappearing - as implied in the Wilderness Society advertisement and have, in fact, being growing in cover for many years (refer to Australian Bureau of Agriculture and Resource Economics, official statistics).

The forest product industry is one of the largest contributors to the Canberra economy and generator of non-public sector jobs. It covers a broad sweep of activities including housing and construction, furniture and sawmilling.

In its exploitation of a popular Christmas theme the Wilderness Society advertisement is particularly offensive to our members.

Given the above, NAFI is surprised that your station has permitted the free broadcast of this advertisement. We would request that it no longer be aired. Should your station fail to take such action, NAFI will immediately instigate legal proceedings.


However, on reviewing the commercial, we have decided to discontinue its broadcast on the grounds of its focus on this contentious issue.
