

DAVID E. BUDDE, being first duly sworn on oath, deposes and says that:

Introduction

1. I am the District Attorney Chief Investigator. I submit this Affidavit to assist the John Doe judge in the above-encaptioned proceeding.
2. I have 24 years of experience as a law enforcement officer. For eight years, I worked in the Milwaukee Metropolitan Drug Unit conducting drug investigations including the use of undercover investigators and confidential informants. I have also served in the District Attorney White Collar Crime Unit and the General Criminal Investigations Unit. I have been Chief Investigator since 1999; nevertheless I have continued in investigative work over the last eleven years. Over these last eleven years, I have overseen multiple police-involved shootings and homicides on behalf of the Milwaukee County District Attorney's Office. I was one of two state case agents in the federal investigation and trial of the Milwaukee Police Department officers involved in the Frank Jude beating (2005 - 2007). I have also worked on major public corruption investigations, including the investigation of former Alderman Michael McGee in 2007 and more recently, the matter involving Milwaukee Police Officers Royce Lockett and Paul Hill, who were charged in federal court in Milwaukee with drug crimes and money laundering.
3. I incorporate by reference all of the Applications, Affidavits and other papers that have been submitted to the court in these John Doe proceedings, especially those papers as noted in the paragraphs that follow.
4. This Affidavit is submitted in connection with a request for a search warrant for all records and information relating to the investigation of political activity carried on by Darlene Wink in the Office of the Milwaukee County Executive in the Milwaukee County Courthouse, 901 North 9th Street, Milwaukee, WI. In this regard, I make particular

reference to Jeff Doss' May 14, 2010 Affidavit in Support of Petition to Enlarge Scope of John Doe Proceedings & in Support of Request for a Subpoena Duces Tecum and Search Warrant. This Doss affidavit describes blog-posting activity by Darlene Wink as "rmpcv" while serving as an employee in the Office of the County Executive. I make further reference to the July 1, 2010 Affidavit of James Krueger submitted in support of a Search Warrant for the Yahoo Mail accounts of Darlene Wink. In this Affidavit, Mr. Krueger described evidence of the use of Wink's county-issued workstation for political communications. Both of these Affidavits tend to establish that Darlene Wink conducted partisan political activity while engaged in her official position as an employee within the Office of the Milwaukee County Executive.

5. Detailed below, based upon new information obtained in large part – if not exclusively – through the process issued in the John Doe investigation, I have discovered additional evidence that Darlene Wink appears to have been engaged in substantial political activity on multiple occasions over a sustained period of time while she was working as an employee in the offices of the Milwaukee County Executive.

PREMISES TO BE SEARCHED

6. I request that the court authorize a search of certain physical premises located in the County of Milwaukee and the State of Wisconsin, specifically the location of 3876 East Holmes Avenue, Cudahy, Wisconsin.

7. City of Cudahy Assessor data published lists the owner of 3876 East Holmes Avenue as Darlene Wink.¹

8. I am advised by District Attorney Investigator Paul Bratonja that on July 28, 2010 he has conducted surveillance at 3876 East Holmes Avenue, Cudahy, Wisconsin and that he has observed Darlene Wink at the property (hereinafter "the Wink premises"). He describes the property as follows:

a. A single family tan brick residence with red and white trim located on the northeast corner of East Holmes and South Hately. The house number "3876" is affixed just east of the front door above the mailbox. On the east side of the residence there is a side screen door entrance. The front screen door of the residence faces south onto East Holmes. The roof of the residence has red and

- grey shingles.
- b. The property also includes a single car garage with white siding and red trim. The single car garage is located north of the home and faces east onto South Hately. The garage has white siding with red trim and has the number "3876" marked on the northeast upper corner of the garage. The garage appears to have the same roofing material as the residence.
- c. Exhibits A, B & C are photos of the exterior of the Wink premises. These photos were supplied to me by Investigator Paul Bratonja. They were taken on July 28, 2010.

9. Paul Bratonja further advises me that he has observed a vehicle kept at the Wink premises. This vehicle, which he has seen Darlene Wink drive, is described as a burgundy 2002 Chevrolet Venture van bearing plate 920CMH. See Exhibit D. Wisconsin Department of Vehicle records for this registration plate indicate that the vehicle is registered to Darlene J. Wink (hereinafter the "Wink Vehicle") at the address of 3876 East Holmes, Cudahy, Wisconsin.

OBJECTS OF THE SEARCH

10. I request that the court issue a warrant to search these premises for all records and information relating to violations of sections 946.12, 11.36 and 11.61 of the Wisconsin Statutes, viz., Misconduct in Public Office and Political Solicitation involving Public Officials and Employees, for the time period since January 1, 2009, including information in any form relating directly or indirectly to political activity while a County employee.

11. I use the terms "records" and "information" to include all items of evidence in whatever form and by whatever means they may have been created or stored, including any form of computer or electronic storage (such as hard disks, jump drives, thumb drives, CDs, DVDs, external USB drives, 3.5" disks or other media that can store data); any handmade form (such as writing, drawing, painting); any mechanical form (such as printing or typing); and any photographic form (such as microfilm, microfiche, prints, slides, negatives, videotapes, motion pictures, photocopies).

12. I use the term "political activity" to include, without limitation, contact for the purpose of campaign activities, the making or soliciting of campaign contributions,

fundraising, and/or lobby activities.

13. I request that the warrant extend to a laptop computer described as an HP Pavilion dv6z Entertainment PC.

14. I request that the warrant extend to cell phones.

15. I request that the warrant extend to a modem described as Cricket Model A600 USB data modem.

16. I request that the court authorize a forensic examination of cell phones, computer equipment and peripheral devices seized during execution, as such forensic examinations are described below and by DA Information Technology Manager James Krueger in his Affidavits dated June 28, 2010 and July 1, 2010. I also refer the court to the Affidavit of Brad Montgomery dated June 24, 2010, especially its contents under the heading of Computers & Electronic Storage beginning at ¶7. I note that these Affidavits submitted by these Information Technology professionals support the proposition that relevant information may be found on a computer for extended periods of time after data is originally created, even to a point in time after the user believes that such data has been "deleted."

PROBABLE CAUSE – MISCONDUCT IN PUBLIC OFFICE & UNLAWFUL ACTIVITY BY PUBLIC EMPLOYEE

Darlene Wink's Partisan Political Activities During Work Hours

17. I know that conducting political activity from government offices is a matter of Misconduct in Public Office in violation of Wis. Stats. §946.12(2).² It is also a potential direct and/or Party to a Crime violation of Wis. Stats. §11.36(2).³

18. I also know that misconduct is defined as conduct that is inconsistent with the duties of one's office, *State v. Schultz*, 306 Wis.2d 598, 743 N.W.2d 823 (App. 2007), and many sources, such as employee handbooks as well as official e-mail and memos, can be used to determine duties associated with an office. *State v. Jensen*, 272 Wis.2d 707, 681 N.W.2d 230 (App. 2004). As relevant to this case, however, the Code of

² Wis. Stats. §946.12(2) provides "No employee may, "[i]n the officer's or employee's capacity as such officer or employee, do[] an act which the officer or employee knows is in excess of the officer's or employee's lawful authority or which the officer or employee knows the officer or employee is forbidden by law to do in the officer's or employee's official capacity.")

Ethics for Milwaukee County is published as part of the County Ordinances and Section 9.06 expressly prohibits political campaigning by County employees.⁴ Likewise, the County Technology Use policy prohibits the use of County computer equipment for political campaign activities.

19. I attach Exhibit E to this Affidavit. It is a spreadsheet⁵ I personally prepared that summarizes e-mails⁶ which I have examined from among those obtained through the execution of the Yahoo search warrant. These e-mails relate to darlenewink@yahoo.com⁷ and rpmcvp@yahoo.com. These e-mails highlight partisan political activity during - or in a few instances, within minutes of – periods of time when Darlene Wink's Ceridian timesheets⁸ indicate that Ms. Wink was working as a county employee.

20. I respectfully submit that this summary of e-mails demonstrates probable cause to establish that Ms. Wink committed Misconduct in Public Office and Unlawful Activity by a Public Employee. I note that the spreadsheet represents a summary of only those e-mails I have thus far closely examined. For the spreadsheet, I have selected days at the beginning (September 2009) and toward the end (April 2010) of a study period. The spreadsheet is not a complete list of the partisan political e-mail activity I have

 - (b) Distribute any campaign literature.
 - (c) Solicit contributions for any candidate.
 - (d) Engage in political campaign activities for any candidate.
 - (e) Circulate nomination papers for elected office.

⁵ Column 1 of this sheet represents the date of the e-mail. Column 2 represents the day of the week. Column 3 shows the official Ceridian timesheet times that Wink worked on that day. The Ceridian system is the timekeeping system used by the County. Column 4 is the time of the message as reflected on the printed e-mail; it is expressed in Pacific Time. Column 5 represents a conversion of Pacific Time to Central Time. Column 6 is the subject line of the e-mail. Column 8, labeled "Content," represents my notes on the content of the e-mail. The last column describes any e-mail attachments.

⁶ Unless otherwise noted in Column 8, the "Content column," these e-mails originated from the rpmcvp Yahoo account.

⁷ In the spreadsheet, I use a shorthand of DW@yahoo to represent the full address of darlenewink@yahoo.com

⁸ In the course of this investigation, through the Office of the Corporation Counsel, Milwaukee County voluntarily turned over the time records for Darlene Wink. I have examined these records and they consistently indicate work hours of 8:00 a.m. to 5:00 p.m. Monday through Friday with a one hour lunch from noon to 1:00 p.m. All darlenewink and rpmcvp e-mails identified in these materials were generated on a day Darlene Wink worked eight hours.

seen in the Wink Yahoo e-mails. The spreadsheet represents, in my opinion, a sampling of an overall, continuous course of similar conduct occurring in 2009 and 2010.

21. As an example of this course of conduct, I ask that the court review the spreadsheet for the date of September 24, 2009 and note:

- a. Seven (7) politically related e-mails were sent throughout the course of the workday;
- b. A principal theme of these e-mails is the budget address given by County Executive (and gubernatorial candidate) Scott Walker to the County Board;
- c. At 11:30 a.m., Wink sends an e-mail to Tim Russell, then the Deputy Chief of Staff in the Office of the County Executive and also, as of September 2009, the Treasurer of the Republican Party of Milwaukee County (RPMC). That e-mail forwards a Press Release Wink has received from David Karst, the chair of the Republican Party of Milwaukee County. The Press Release is written on RPMC letterhead. It is in the name of David Karst. It regards Scott Walker's budget address to the County Board and the party's support for that budget;
- d. At 1:06 p.m., Wink asks the RPMC chairperson to review the Press Release "as I [Darlene Wink] would like to send this out."
- e. At 2:29 p.m., Wink sends a list of media contacts from darlenewink@yahoo.com to rpmcvp@yahoo.com .
- f. At 3:00 p.m., Tim Russell sends back an edited version of the Press Release.⁹
- g. At 5:04 p.m., Wink sent the Press Release to media contacts stating "Please see the attached Press Release from Milwaukee County Chairman David Karst regarding Milwaukee County Executive Scott Walker's Budget Address." See Exhibit F.

⁹ Ceridian records indicate that Russell took four hours of vacation time on September 24, 2009.

22. As a further example, I ask that the court review the spreadsheet for the date of September 25, 2009 and note:

- a. At 9:16 a.m., Wink – using darlenewink@yahoo.com – forwards an e-mail from Joe Fadness (identified as the Operations Manager for the Friends of Scott Walker on various Internet sites, including Linked In) to Wink’s second Yahoo account at rpmcvp@yahoo.com. The topic of the e-mail is a Scott Walker birthday fundraiser set for November 6, 2009. As an attachment, it contains a copy of the fundraiser invitation and asks for Wink’s thoughts.
- b. At 9:23 a.m., Wink replies to Joe Fadness, the Operations Manager, commenting on the classification of political donors and offering comments on the text of the Fadness draft invitation. See Exhibit H.
- c. The draft invitation (Exhibit H) clearly indicates “Paid for by the Republican Party of Milwaukee County”.

23. I also note selected activity on April 9, 2010 as follows:

- a. At 8:06, in an e-mail to Herb Ripka, the Secretary of the RPMC, Wink acknowledges Internet links received from Ripka to <http://milwaukee.wisgop.info/2010/04/08/wisonsinates-oust-incumbents> and <http://milwaukee.wisgop.info/2010/04/08/republicans-blast-wisconsin-health-care-office>;
- b. At 8:11 a.m., Wink sends copies of a CNI newspaper article headlined “Republicans Hosting Tax Rally, Congressman Paul Ryan Speaker” to multiple members of the Republican Party of Milwaukee County;
- c. At 10:02 a.m., Wink writes to RPMC chairman David Karst, “Here is another release. Let me know what you think.” The e-mail, Exhibit I, is drafted on RPMC letterhead with the heading “Republicans Urge Residents to Call State Representatives and Gubernatorial Governor (sic) Tom Barrett regarding new proposed Election Laws.”
- d. At 11:35, Wink e-mails RPMC Chairman David Karst regarding a proposed luncheon for delegates at the party’s convention, at which luncheon the delegates will disclose “how are individuals are going to vote.” Wink writes that this is not a good use of their time. Rather than a luncheon, she

proposes polling the delegates and then telling "Reince" (an apparent reference to Reince Priebus, head of the Republican Party of Wisconsin) how the Milwaukee County delegates will vote.

24. Finally, I note selected activity on April 19, 2010, concerning the RPMC endorsement of Scott Walker for Governor, as follows:

- a. At 7:51 a.m., Wink writes to RPMC Chair David Karst "Do you know what is being done about a release for the endorsement on Friday?" Karst subsequently responds, "If you would like to do a release that would be fine."
- b. At 11:39 a.m., Wink replies to Karst, "[H]ere is your press release – let me know if I can send it out – thanks." A copy of that e-mail, with the attachment is made part of this Affidavit as Exhibit I.

Darlene Wink's Use of a Laptop Computer and a Wireless Internet Connection to Work at the Courthouse.

25. I have received and reviewed basic subscriber information for the accounts identified as darlenewink@yahoo.com and rpmcvp@yahoo.com provided by Yahoo in connection with the response to the court's Search Warrant dated July 1, 2010.

According to these Yahoo records:

- a. The account darlenewink was created on November 10, 2003 with the full name of "Mr. (sic) Darlene Wink." A birth date of September 14, 1950 is listed. The Wisconsin Department of Motor Vehicles lists September 14, 1950 as Darlene's actual date of birth, according to Investigator Paul Bratonja.
- b. The account rpmcvp@yahoo.com was created on September 21, 2009 with the full name of "Ms. RPMC VP." A birth date of September 14, 1950 is listed. A "commchannel" listing is provided as darlenewink@yahoo.com.

26. I have received and reviewed IP address¹⁰ login information for the account darlenewink@yahoo.com. See Exhibit J. Exhibit J is a chart developed by Jim Krueger using IP address login data provided by Yahoo for the account

¹⁰ Jim Krueger advises that an IP address or Internet Protocol address is a number assigned to a networked device, including a computer workstation, so as to distinguish each network device from every other network device anywhere on the network. An IP address is usually in dotted decimal form, e.g. 10.123.22.244.

darlenewink@yahoo.com . The source of this information was provided as part of Yahoo's response to the court's Search Warrant dated July 1, 2010. Exhibit J shows logins by dates and times (both in Greenwich Mean Time and Central Time Zone Time). The exhibit identifies a login by a unique internet IP address. This address provides information about the network from which the login is made.

27. According to IT Manager Jim Krueger, IP addresses (or rather blocks of IP addresses) are assigned to and controlled by different companies. For example, Milwaukee County is assigned a range of IP addresses. They are some permutation of the IP address 204.194.25x.xxx (where "x" is a varying number).

28. Referring to Exhibit J, the John Doe judge will note that the IP addresses listed for the logins before 9:30 a.m. CDT on September 21, 2009 are almost exclusively some variation of the IP address 204.194.25x.xxx. According to Jim Krueger, a login with an IP address like 204.194.25x.xxx. signifies a login from the Milwaukee County network to the darlenewink@yahoo.com account. We may fairly infer from these facts that Wink was using a county computer to log into her Yahoo accounts, according to Jim Krueger.

29. On Exhibit J, the court will note that, after September 21, 2009 (a date close in time to Darlene Wink's purchase of a laptop computer as described below), the logins to darlenewink@yahoo.com change to IP addresses that predominantly are a form of the IP address 69.171.163.xxx (where "x" is a variable number).

30. James Krueger states that he has consulted a web service known as "utrace." This service, which he states he has used and found to be reliable in the past, indicates that an IP address in the range of 69.171.163.xxx is controlled by Cricket Communications.

31. Attached as Exhibit K is a second document that is based on information supplied by Yahoo and prepared by Jim Krueger. This is the IP address login information for rpmcvp@yahoo.com. That log sheet shows logins by dates and times (both in Greenwich Mean Time and Central Time Zone Time).

32. The court will note that many of the login times on Exhibits K and L occur Monday through Friday, 8:00 a.m. to 5:00 p.m. during the workday.

33. In the Dan Bice newspaper article (see Exhibit A to the Doss Affidavit in Support of the Petition to Enlarge Scope dated May 14, 2010), I have read that Ms. Wink stated

to Mr. Bice that "she brings a personal laptop to work and posts most – and perhaps all – all of her [blog] comments using it, not a county computer." This statement is confirmed in a handwritten note that I found in Darlene Wink's office on June 3, 2010. That note, apparently a summary of her conversation with Dan Bice, states "I told him that I used my laptop computer. I never told him that I was doing campaign work on county time. . . ."

34. For the reasons set forth below, I believe that Darlene Wink was using a laptop computer with a wireless internet modem from her offices in the Milwaukee County Courthouse. Further, I believe that the partisan political e-mail work summarized in my spreadsheet attached as Exhibit E was likely accomplished using that personal laptop.

35. As an initial matter, I know as a matter of common sense and personal experience that it is possible to purchase a wireless modem device and use it in conjunction with a laptop computer. Based on my review of Internet ads published by Cricket Communications, I know that Cricket offers such a product and wireless plan for sale.

36. I also believe, based on documents obtained from Darlene Wink's office on June 3, 2010, that Darlene Wink purchased a laptop computer that was ordered in late August 2009. Papers in the office include an order confirmation for an HP Pavilion Entertainment dv6z customizable Notebook PC. According to the HP Official Store internet site, the specifications for the dv6z indicate that this model has 4 USB ports.

37. Among her office papers, I also reviewed an "Order Shipped" confirmation e-mail dated September 3, 2009 and sent to darlenewink@yahoo.com for this HP laptop computer. The estimated shipping time was five to seven business days.

38. I also found the following papers in the Darlene Wink office on June 3, 2010:

- a. A Cricket order confirmation for the purchase of a Cricket A600 Modem and the purchase of a monthly Broadband Internet service.
- b. A Cricket Personal Account Information Sheet containing handwritten information as follows:
 - i. First Name: Darlene
 - ii. Last name: Wink
 - iii. Street Address: 3876 E Holmes Avenue
 - iv. City: Cudahy

- v. State / Zip: WI 53110
 - vi. Acct. #: 235-2424622-1
 - vii. Phone #: 414-301-9653
 - viii. 262-661-6777 (Min Mdn)
 - ix. ESN #: 128 06177823
(805E441F)
 - x. Purchase Date: 09-15-2009;
- c. A UPC Code sheet including the model number (A600), SKU (CRKA600KIT), MEID DEC (270113178502992263) and pESN HEX (805E441F) for a USB data modem; and
 - d. A Packing Slip for the Cricket A600 showing a date shipped of "2009-09-15" and a Ship To address of 901 North 9th Street, Suite 306, Milwaukee, Wisconsin. This is the address of the Office of the Milwaukee County Executive.

39. Based upon my experience as a police investigator and based on my own life experience, I know that cell phones will contain data relating to the names and numbers of persons called frequently, sometimes called Contacts or Phone Directory. It is also likely to contain a history listing of Calls Placed and Calls Received. Text messages may also be stored on cell phones.

40. I also know that certain computer equipment and computer programs are capable of examining and capturing all of the data found on each of these two computers. I further know that law enforcement agencies like the State Division of Criminal Investigation and the High Technology Unit of the Milwaukee Police Department are capable of conducting a forensic analysis of these cell phones and I know that the High Technology Unit can extract this data for examination.

41. I believe that data relating to call history, contact information and text messages will be valuable evidence in this investigation. Call Contacts information will provide a directory of numbers to political contacts such as David Karst and Joe Fadness. With these numbers and their associated names, investigators will be able to determine the frequency with which Darlene Wink was making cell phone calls for probable partisan political activity during hours she was working as a County employee.

PROBABLE CAUSE TO BELIEVE THESE ITEMS ARE EVIDENCE OF CRIME AND WILL BE FOUND ON THE PREMISES

42. I respectfully submit that a search of the Wink Premises will likely produce records and information productive to this investigation in that:

- a. Inasmuch as Darlene Wink maintained a Yahoo account since 2003, it is probable that she has personal Internet access within her home. This suggests she owns a personal computer that she maintains in her home, which itself may contain additional digital information that can be linked to Ms. Wink's partisan political activities;
- b. The laptop computer is likely stored in her home or in her vehicle;
- c. Digital storage devices containing information regarding Ms. Wink's political activity like CDs, jump drives and the like are probably present in her home;
- d. Contact information for persons associated with the Friends of Scott Walker and/or the Republican Party will likely be found in the home.

43. I respectfully submit that a search of the Wink Vehicle will likely produce records and information productive to this investigation in that any of the aforementioned items, with the possible exception of a desktop computer, could be transported in a vehicle.

44. I note that the HP laptop is likely to contain remnant evidence of the connections to Yahoo and it is likely to contain documentary evidence relating to the work believed to have been completed on "county time" using the laptop computer.

45. The Cricket cell phone may have evidence of "Contact information" and call history; it is valuable for that reason.

46. The Cricket modem is an instrumentality of the suspected crimes in this investigation and therefore has intrinsic worth for purposes of this inquiry.

CONCLUSION


47. Based on my training and experience, for all the foregoing reasons, I request the court to issue a search warrant for the Wink Premises and the Wink Vehicle. I ask that the court authorize the seizure of the items described above, including a forensic search of any cell phones and digital evidence that may be recovered.
